## Union Bay Improvement District conversion proceeds

In November 2020, residents in Union Bay voted 72 per cent in favour of converting its water, fire protection and street lighting services to the CVRD. The conversion date has been set for July 1, 2021, pending provincial approval.

The CVRD and Union Bay Improvement District are now working together to plan the transition ahead. An advisory group has been established, including representatives from the Union Bay Improvement District and CVRD boards, staff and ratepayers, and the provincial government to undertake the formal legal process to convert the services.

### Sewer extension update expected in spring

The CVRD team is continuing assessment work on the possible extension of sewer service to Royston/Union Bay while we await an update on a grant application made in 2020. This information will better outline estimated costs for residents - and once in hand, the CVRD remains committed to consulting the community. This proposed service would not move forward without direction from the residents and homeowners.

We had expected to start engagement sooner - but COVID-19 has delayed processes. We hope to come to the community with more information in the spring.

# Making it easier to weigh in

A new once-a-year Alternate Approval Process (AAP) for the CVRD has been approved to increase transparency and make it easier for the public to provide input.

An AAP is available to local governments to seek community approval on certain initiatives. It requires those who are opposed to the proposal to submit a form indicating their opposition. In fall 2020, it was proposed that grouping together multiple AAPs once a year could improve efficiencies, reduce costs, and make it easier for the community to keep track of AAPs that are ongoing.

With the proposed approach approved, the directors will move forward with one singular AAP this spring. Expected to be included in the first one is:


- Electoral Areas Community Hall Service Establishment

# Spring updates on roadside garbage/recycling proposal

Residents in rural areas will hear more this spring about the proposed roadside garbage and



In 2020, residents were asked to weigh in on a possible roadside collection program and the CVRD received more than 3,000 submissions from the community indicating support in the majority of areas discussed.

The project team is now working out the details about how the program can be delivered in the 11 communities that expressed interest. Another round of public outreach will happen this spring when residents receive more detailed information about boundaries, service levels and possible exemptions to the service.

#### Denman Island:

- · Kirk Road stairs, connecting pedestrians from the Denman West ferry terminal to the downtown core, are now open

#### Hornby Island:

- New washroom and improved access at Sandpiper Beach Park
- · New trail has been constructed along the unopened Gull Road dedication, with finishing improvements expected this spring
