### **BYLAW NO. 2266**

# A Bylaw to Convert the Comox Valley Animal Control Function to an Extended Service

**WHEREAS** supplementary Letters Patent were issued to the Regional District of Comox-Strathcona on the 3rd day of September, 1981 which granted the function of Animal Control in Electoral Areas 'B' 'C' and that portion of Electoral Area 'A' situated on Vancouver Island;

**AND WHEREAS** pursuant to Section 775(4) of the Municipal Act, where a Regional Board exercises a power to provide a service under Section 775(3), the Regional Board may adopt a bylaw in accordance with Section 775(5) which converts the service to an extended service, exercised under the authority of an establishing bylaw;

**AND WHEREAS** the Regional Board wishes to convert the supplementary Letters Patent providing for Animal Control in Electoral Areas 'A', 'B' and 'C' to an extended service under Section 775(5) of the Municipal Act;

**AND WHEREAS** by Letters Patent dated September 9, 1999, Electoral Area 'K' was created which includes that area comprised of Denman Island and Hornby Island which were originally included within the boundaries of Electoral Area 'A"

**AND WHEREAS** the Directors of Electoral Areas 'A', 'B' and 'C' have consented to the adoption of this Bylaw;

**NOW THEREFORE** the Regional Board of the Regional District of Comox-Strathcona in open meeting assembled enacts as follows:

#### Service

- 1. (a) This service shall hereby be known as the Electoral Areas A (Baynes Sound), B and C Bylaw Enforcement Service.
  - (b) The service established by this bylaw is to provide animal control, noise control, control of unsightly premises, and regulation of fireworks to the Electoral Areas A (Baynes Sound), B and C Bylaw Enforcement Service Area.

### **Boundaries of the Service Area**

2. The boundaries of the Electoral Area A (Baynes Sound), B and C Bylaw Enforcement Service Area shall be those portions of Electoral Areas A, B, and C as outlined on the map shown in Schedule A.

## **Participating Area**

3. Electoral Areas 'A', 'B' and 'C' are the participating areas in this extended service.

# **Cost Recovery**

- 4. As provided in section 378 of the *Local Government Act (RSBC, 2015, C. 1)*, the annual cost for this service shall be recovered by one or more of the following:
  - (a) property value taxes;
  - (b) fees and charges;
  - (c) revenues raised by other means authorized by the *Local Government Act (RSBC, 2015, C. 1)* or another Act; and
  - (d) revenues received by way of agreement, enterprise, gift, grant or otherwise.

#### **Maximum Amount**

5. The maximum amount that may be requisitioned for this extended service under Section 817(1) of the Municipal Act for this service is the product obtained by multiplying the net taxable value of land and improvements within the service area by a property tax value rate of \$0.27 per \$1,000 of assessment for Regional Hospital District purposes.
