## **BYLAW NO. 100**

### **A BYLAW FIXING TOLLS FOR 2023 IN THE IMPROVEMENT DISTRICT, AND PROVIDING, WHEN LEGALLY PERMITTED, FOR THE LEVY OF AN ADDITIONAL AMOUNT TO ENCOURAGE PROMPT PAYMENT**

The Trustees of the Graham Lake Improvement District (District) ENACT AS FOLLOWS:

#### **1. Non-Metered Water Rates**

(a) In respect of each single-family dwelling, an annual toll of: \$1600.00

(b) In respect of each parcel of land with no dwellings to which water is made available by the District, an annual toll of: \$700.00.

#### **2. Non-Metered Water Rates for Outside Service Areas**

a) In respect of each single-family dwelling, an annual toll of: \$1600.00

b) In respect of each parcel of land with no dwellings to which water is made available, an annual toll of: \$700.00.

3. The aforesaid tolls shall be due and payable on or before the 31st day of March, 2023 for the calendar year 2023. Any tolls remaining unpaid after the due date shall have added thereto, when legally permitted, an amount of \$90.

4. The District may, by resolution, order the water shut off to any premises or parcels of land on which there are tolls or other charges owing for 90 days or longer from the due date. Water shut off under this section shall be subject to a reconnection charge of \$50.

5. This Bylaw repeals Bylaw **Water Tolls Bylaw 2022 No. 98**.

6. This Bylaw is effective on January 1, 2023.

7. This Bylaw may be cited as the **"Water Tolls Bylaw 2023 No. 100"**.
