BYLAW NO. 244

A bylaw to adopt regulations for the Comox Valley exhibition grounds service to impose fees and other charges for use of the Comox Valley exhibition grounds

WHEREAS the board adopted Bylaw No. 136 being "Comox Valley Exhibition Grounds Service Conversion Bylaw No. 136, 2010" on the 23rd day of November 2010 to convert the exhibition grounds function to the Comox Valley exhibition grounds service;

AND WHEREAS the board may, by bylaw, regulate the activities under the service;

NOW THEREFORE the board of the Comox Valley Regional District in open meeting assembled enacts as follows:

Citation and effective date

1. This Bylaw No. 244 may be cited as the "Comox Valley Exhibition Grounds Fees and Charges Bylaw No. 244, 2013" and takes effect on April 1, 2013.

User rates

2. The fees and charges set out in schedule 'A' hereto are hereby imposed on persons using the Comox Valley exhibition grounds or participating in recreation or other programs offered by or in connection with the Comox Valley exhibition grounds and shall be paid in accordance with schedule 'A' hereto attached.

Repeal

3. Bylaw No. 2006 being "Comox Valley Exhibition Grounds Fees and Charges Bylaw No. 2006, 1998" and all amendments thereto are repealed on the effective date of this bylaw.

Schedule A

Comox Valley Regional District – Exhibition Grounds

Schedule of Fees and Charges

SECTION 1 GENERAL

1.1 Implementation of Fees:

Fees will be implemented on October 1, 2023 as identified in this schedule.

1.2 Definitions:

- A) **Commercial:** Any individual, company or organization engaged in the pursuit of business for profit through the use of the Comox Valley Exhibition Grounds.
- B) **Daily Rate:** Renters will be charged a daily rate for each day of use starting from their arrival on site until they leave the site. This includes set up/take down time. Overnight use beyond 10:00 AM the next day will be considered a second day of use.
- C) **Family:** A household of people up to a maximum of 6 persons, minimum 1 adult and 1 child/teen.
- D) **Large Event:** Any event that requires the use of 4 or more fields and/or riding rings combined will be considered a large event and must use the large event rental package option.
- E) **Not for Profit:** Community associations utilizing the Comox Valley Exhibition Grounds and any group registered as a charity with the Canada Revenue Agency.
- F) **Regular User Groups:** Organized groups renting the Comox Valley Exhibition Grounds with rentals of over 10 hours per month.

1.3 Additional Charges:

- A) The Comox Valley Exhibition Grounds reserves the right to charge set-up and tear down rates for rented space on a cost recovery basis.
- B) Third party costs incurred by the Comox Valley Exhibition Grounds on behalf of users of the facility will be charged back to the user on a cost recovery basis.

1.4 Promotional Events:

Any CVRD officer has the discretion to waive or reduce the fees and charges as set out in this schedule for promotional purposes and special events.

1.5 New Programs and Services

Any CVRD officer or the Senior Manager of Recreation Services has the authority to establish fees for new programs and services.

1.6 Tax Implications

Taxes will be added to fees where noted throughout as required by legislation from time to time.
