



2024-2028 Recommended Plan - Operating






Operating Budget - Proposed to Recommended \$9.9MM Change

Key Changes

- 360 Hornby Island Garbage Disposal Service: \$150,000 added for paving at the Hornby Island Recycling depot.
- 670 Hornby Island Community Facilities Service: \$17,500 added to support the operation of the Hornby Island Arts Centre.
- ➤ 675 Denman Island Community Facilities: \$15,000 add to tax requisitions annually to be transferred to reserves.
- ➤ 676 Puntledge North Community Facilities: \$15,000 add to tax requisitions annually to be transferred to reserves.
- \$10,000 added to 621 Baynes Sound, Electoral Area B and C Parks and Greenway Service to support weed control efforts on beach accesses.
- Comox Valley Food Policy Council: \$20,000 added to include the Board endorsed one-time 2024 regional grant
- 2023 year end surplus incorporated into the 2024 recommended budget is \$12.8MM



2024-2028 Proposed Financial Plan – Capital





Capital Budget- Proposed to Recommended \$8.8MM Change

Key Changes

- Project No. 1180 New Turf Field (\$5,718,000)
- Project No. 1127 King Coho Sewer Upgrades: \$123,000 increase to address current cost projections.
- Union Bay Playground and Trail Project: \$90,000 increase to allow for enhanced scope of work.
- 2023 Carry forward Capital Projects fully incorporated into 2024 budget.


