





Sandwick Waterworks Conversion Project Update

In July 2016, the Comox Valley Regional District (CVRD) approved the request of the Sandwick Waterworks District (SWWD) to convert its water supply and distribution services for electoral area B residents to the CVRD's regional water system. The CVRD employs certified, full-time employees to operate and manage its water systems and this team will become responsible for the Sandwick system on January 1, 2017.

On the same date, Sandwick residents living within the City of Courtenay boundary will begin paying for their water services through the City of Courtenay.


Sandwick electoral area B residents can make payments at the CVRD office starting on January 3, 2017. Payments will be accepted by cash, cheque, debit or credit card.

Payments for 2016 water bills can be made at the Sandwick Waterworks District office until January 26, 2017 in the form of cash or cheque.

Any Sandwick customers residing within the City of Courtenay boundary will make their water bill payments at the City of Courtenay municipal offices. For more information please contact the City of Courtenay at info@courtenay.ca









Project Costs

In April 2016, the CVRD board of directors voted in favour of contributing \$307,000 of area B's gas tax funding to help cover the cost of connecting electoral area B Sandwick residents to the Comox Valley regional water system. These funds will cover most, if not all, of the system modifications that are required for physical conversion to the regional system. Home owners will be required to pay their share of any outstanding costs of the physical conversion and water meter installation, as well as a one-time connection charge. Working with the City of Courtenay, the CVRD has also recently submitted an application for funding to the federal Clean Water and Wastewater Fund to assist with these costs.

Without additional grant funding, the total cost of converting to the regional water system is estimated at \$4,902 per single family home. Residents will have the option to make a one-time payment or spread the cost over 10 years by way of an annual parcel tax that is payable on the property tax notice. Details about payment options will be made available early next year.

Billing

Sandwick electoral area B property owners will receive their annual water bill from the CVRD in June 2017. Bills are sent to the property owner and landlords are responsible for costs on behalf of their tenants, including any outstanding amounts owed from previous years. Annual water bill payments can be made at the CVRD office by cash, cheque, debit or credit card.

Project Background

The SWWD was incorporated by letters patent in April 1960 and has delivered potable water to its residents since 1965. During their annual general meeting of 2013, the SWWD board of trustees supported a resolution requesting the CVRD initiate a study of the options and costs associated with converting to a regional district service. This request was based on challenges around water supply and sources, health authority regulations pertaining to surface water treatment and organizational capacity. Three years later, the SWWD decided to disband and convert to the CVRD service area. The CVRD approved the decision and the transfer date for the services was set at January 1, 2017.
