Purpose

The purpose of this report is to announce the Hornby Island fire service loan authorization bylaw assent voting official results.

Policy analysis

The Comox Valley Regional District operates the Hornby Island fire protection service under Bylaw No. 2011 being "Hornby Island Fire Protection Local Service Establishment Bylaw No. 2011, 1998". The current financial plan identifies the construction of a new Hornby Island fire hall in 2015. Section 819 of the *Local Government Act* and section 179 of the *Community Charter* authorizes the Comox Valley Regional District (CVRD) to borrow funds for capital construction purposes within its powers by way of loan authorization bylaw.

Executive summary

Assent voting (referendum) was conducted on April 18, 2015 to seek elector approval for Bylaw No. 362 being "Hornby Island Fire Protection Service (Fire Hall Construction) Loan Authorization Bylaw No. 362, 2015". Following the chief election officer's recount, the official results of the assent voting are:

YES – 616 ballots cast (83%) NO – 126 ballots cast (17%)

Elector approval for Bylaw No. 362 has been obtained and the board may now consider adopting Bylaw No. 362.

Further voting statistics are presented in appendix 'A'.
