

**REGIONAL DISTRICT OF COMOX-STRATHCONA**

**BYLAW NO. 2827**

**A BYLAW TO ESTABLISH THE SARATOGA / MIRACLE BEACH SEWERAGE SERVICE**

**WHEREAS:**

- A. Under section 796 of the *Local Government Act* a regional district may operate any service the Board considers necessary or desirable for all or part of the regional district;
- B. The board of the Regional District of Comox-Strathcona wishes to establish a service for the collection, conveyance, and disposal of sewage;
- C. The approval of the inspector of municipalities has been obtained under section 801 of the *Local Government Act*; and
- D. The approval of the electors in the participating area has been obtained by vote in accordance with section 801.2 of the *Local Government Act*.

NOW THEREFORE the board of the Regional District of Comox-Strathcona in open meeting assembled enacts as follows:

**CITATION**

- 1. This bylaw may be cited for all purposes as the “Saratoga / Miracle Beach Sewerage Service Establishment Bylaw No. 2827, 2006”.

**SERVICE**

- 2. The service established by this bylaw is the Saratoga / Miracle Beach Sewerage Service (the “Service”) for the collection, conveyance, and disposal of sewage in the Service area.

**BOUNDARIES**

- 3. The boundaries of the Service are that part of Electoral Area ‘C’ shown outlined on the map attached to this bylaw as schedule ‘A’.

**PARTICIPATING AREAS**

- 4. The participating area for the Service is that portion of Electoral Area ‘C’ shown on schedule ‘A’ as the Service area referred to in the preceding section 3 of this bylaw.

**COST RECOVERY**

- 5. As provided in section 803 of the *Local Government Act*, the annual cost of providing the Service shall be recovered by one or more of the following:
  - a) property value taxes imposed in accordance with division 4.3 of part 24 (Requisition and Tax Collection) of the *Local Government Act*;

- b) parcel taxes imposed in accordance with division 4.3 of part 24 (Requisition and Tax Collection) of the *Local Government Act*;
- c) fees and charges imposed under section 363 (Imposition of fees and charges) of the *Local Government Act*;
- d) revenues raised by other means authorized by the *Local Government Act* or another act; and
- e) revenues received by way of agreement, enterprises, gift, grant or otherwise.

#### MAXIMUM REQUISITION

6. In accordance with section 800.1(1)(e) of the *Local Government Act*, the maximum amount that may be requisitioned annually for the cost of the service established by this bylaw is \$749,000.
