2. If your application is filled out correctly, the Comox Valley Regional District will send you a mail ballot package on or about October 1, 2018.
3. If we receive your application after October 1, 2018 time may not permit mailing, so you should arrange to pick up a package from 600 Comox Road, Courtenay, B.C.
4. You are responsible to ensure that your completed ballot package is received by the Chief Election Officer at 600 Comox Road, Courtenay, B.C., V9N 3P6 no later than 4:30 pm on Friday, October 19, 2018 or delivered to the Presiding Election Official at the Comox Valley Regional District boardroom at 550B Comox Road, Courtenay, BC, between 8:00 a.m. and 8:00 p.m. on Saturday, October 20, 2018.
