**REGIONAL DISTRICT OF COMOX-STRATHCONA****BYLAW NO. 1886****A Bylaw to Convert the "Comox Valley Water Specified Area" to a Local Service and to Extend the Boundaries of the Local Service Area.**

**WHEREAS** Bylaw No. 559 cited as "Comox Valley Water Specified Area Merger Bylaw, 1981" was adopted January 25, 1982 and merged the Little River Specified Area and the Back Road/Lake Trail/Headquarters Special Service Area into the Comox Valley Water Specified Area;

**AND WHEREAS** the boundaries of the Comox Valley Water Specified Area were amended by Bylaw No. 688, cited as the "Comox Valley Water Specified Merger Bylaw, 1981, Amendment Bylaw No. 1" which was adopted by the Regional Board on April 30, 1984;

**AND WHEREAS** the Regional Board of the Regional District of Comox-Strathcona has been requested, by petition, pursuant to Section 801 of the Municipal Act, to extend the boundaries of the Comox Valley Water Specified Area to include District Lot 189, Comox Land District;

**AND WHEREAS** the Regional Board of the Regional District of Comox Strathcona wishes to amend the boundaries of the Comox Valley Water Specified Area and convert the Comox Valley Water Specified Area to a local service exercised under the authority of a bylaw establishing the service and by the same bylaw amend the power to the extent that it could if the power were in fact exercised under the authority of a bylaw establishing the service;

**AND WHEREAS** the Directors of Electoral Areas B and C have consented to the adoption of this Bylaw;

**NOW THEREFORE**, the Regional Board of the Regional District of Comox-Strathcona, in open meeting assembled, **ENACTS AS FOLLOWS:**

**1. Local Service Established**

- 1) The service established by this bylaw is for the supply, treatment, conveyance, storage and distribution of water and is formed by expanding the boundaries of the Comox Valley Water Local Service to include the Sandwick, Greaves, Arden, England and Marsden/Camco areas.
- 2) The service shall be known as the Comox Valley Water Local Service (the 'service').

**2. Boundaries of the Service Area**

The boundaries of the "Comox Valley Water Local Service Area" are outlined in heavy black on the plan attached to this Bylaw as Schedule "A".

**3. Participating Areas**

Electoral Areas A, B and C include the participating areas for this local service.

**4. Cost Recovery**

As provided in section 378 of the *Local Government Act* (RSBC, 2015, C. 1), the annual cost for this service shall be recovered by one or more of the following:

- (a) parcel taxes;
- (b) fees and charges imposed under section 397 of the *Local Government Act* (RSBC, 2015, C. 1).

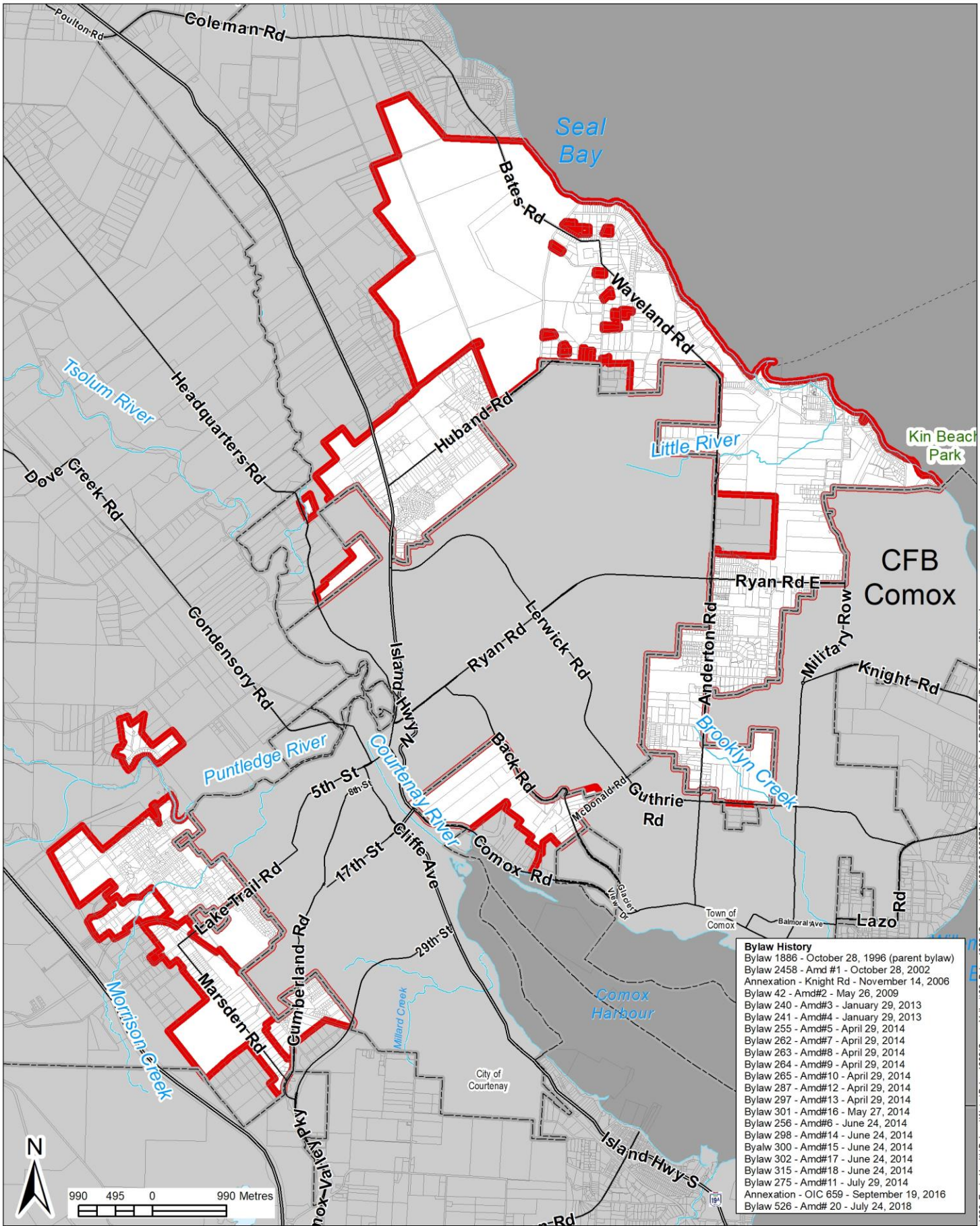
**5. Maximum Requisition**

In accordance with section 339(1)(e) of the *Local Government Act*, the maximum amount that may be requisitioned annually for the cost of the service is the greater of \$167,500 or \$0.1335 per \$1,000 applied to the net taxable value of land and improvements for regional hospital district purposes.

**6. Citation**

This Bylaw may be cited as **"Comox Valley Water Local Service Establishment (Conversion) Bylaw No. 1886, 1996"**.
