CONSOLIDATED BYLAW NO. 2253

**A bylaw to establish a local service area
for community parks on Denman and Hornby Islands**

WHEREAS supplementary Letters Patent were issued on the 9th day of September, 1999 and amended by supplementary Letters Patent issued March 30, 2001 which created a new Electoral Area in the Regional District of Comox-Strathcona, known as Electoral Area ‘K’ and established a community parks service for Electoral Area ‘K’;

AND WHEREAS the Board of the Regional District of Comox-Strathcona wishes to establish a separate Community Parks Local Service Area for Electoral Area ‘K’

AND WHEREAS consent of the Electoral Area ‘K’ Director has been obtained;

NOW THEREFORE the Regional Board of the Regional District of Comox-Strathcona in open meeting assembled enacts as follows:

Local Service Established

1. The service established by this bylaw is the Hornby Island community parks and greenways service. 385

Boundaries of the Service Area

2. The boundaries of the service area shall be that portion of Electoral Area ‘A’ (Baynes Sound – Denman/Hornby Islands) of the Comox Valley Regional District as shown on the attached schedule ‘A’. 385

Participating Area

3. The participating area is Hornby Island, which is part of Electoral Area ‘A’ (Baynes Sound – Denman/Hornby Islands). 385

Cost Recovery

4. As provided in section 803 of the *Local Government Act*, the annual cost of providing the service shall be recovered by one or more of the following:
 - (a) property value taxes;
 - (b) parcel taxes;
 - (c) fees and charges;
 - (d) revenues raised by other means authorized by the *Local Government Act* or another act; and
 - (e) revenues received by way of agreement, enterprises, gift, grant or otherwise.132

Maximum Requisition

5. The maximum amount that may be requisitioned under Section 806(1) of the Local Government Act for this service is the product obtained by multiplying the net taxable value of land and improvements within the service area by a property tax value rate of \$0.50 per \$1,000.00 of assessment for Regional Hospital District purposes.

Citation

6. This bylaw may be cited for all purposes as “Electoral Area ‘K’ Community Parks Local Service Area Establishment Bylaw No. 2253, 2000”.
